Introduction

On July 29 – August 2, 2024, one-week summer school was held at Ganja State University with

the participation of experts from Azerbaijan higher education institutions Khazar University, Baku

State University, Azerbaijan Technical University, Academy of the State Customs Committee,

Ganja State University (GSU), Nakhchivan State University (NSU), Lankaran State University

(LSU), Mingachevir State University (MSU) and experts from EU HEIs L'Aquila University of

Italy (UNIVAQ), Jyvaskyla University of Finland (JYU), Izmir Institute of Technology (IZTECH)

of Türkiye. The participants were given an overview of the following topics: principles and

advantages of open access, which can be achieved with the help of institutional repositories; the

process of installing the institutional repository at the initial stage by the DSpace platform and the

procedure for configuration changes; the necessary capacity (infrastructure and staff/services);

motivation for the creation of Dspace.

Participants were also presented with an overview of reference models that would help improve

the range of services and infrastructure required to effectively manage and maintain access to

research results.

During the 5-day summer school, representatives of European universities delivered their

experiences to participants of partner Azerbaijani higher education institutions.

Theoretical Foundations (Day 1)

Monday, July 29, 2024

The summer school was officially hosted by Ganja State University. The first day of training began with the registration of university representatives. In order for the project to be more successful and useful in the future, two important meetings were held before the official opening of the Summer School, which were very important for political support. During the first meeting, the leaders of the partner universities — Rector of Khazar University Irada Khalilova, head of Development Office Razia Isaeva, rector of GSU Yusif Yusibov, Advisor to the BSU Rector for Digitalization and Information Technologies -Shabnam Safarova, International Affairs Vice Rector of AZTU- Fariz Mammadov, Head of Department for Education and Methodology of ASCCA-Islam Huseynov, Innovation and Science Vice Rector of NSU- Elsever Asadov, Head of the Science and Innovation Department of MSU -Vugar Mustafayev, Library Director of IZTECH - Gultekin Gurdal met in the 10-minute session and discussed the importance of the DIRNA project and how it can benefit the development.

The Director of the Development of Khazar University, Razia Isaeva, greeted the guests, participants, and hosts declared the Summer School open, and asked the Rector of Ganja State University, Professor Yusif Yusibov, to deliver a welcome speech. He made an inspiring welcoming speech and spoke about the importance of the DIRNA project and cooperation among the universities. He highlighted the successful implementation of the project and shared his and his colleagues' contentment with hosting the Summer School and having an opportunity to contribute to a regional impact on the project's outcomes.

Then the rector of Khazar University, Associate Professor Irada Khalilova greeted the participants, thanked the host and emphasized the importance of Open Science. She has provided her own experience of using Institutional Repositories (IR) and

The day followed with the substantive presentation of Gultekin Gurdal from IZTECH on the importance of open scientific and institutional repositories. This session, held in Turkish, emphasized the role of Open Science in modern research and the important role of institutional repositories in making research results accessible. He has provided detailed information on the importance of Open Science, Institutional Repositories (IR) and details of DSpace, their implications, impact on Open Science and institutional improvements.

During the second part of the day, Anna Tozzi from UNIVAQ presented a comprehensive overview of the principles and benefits of open access and open science, while another UNIVAQ representative, Francisco Tarquini, took to the Internet to talk about the importance of open-access publications. This was followed by a detailed presentation by UNIVAQ, led by Grazia di Bartolomeo, Director of the Library Information Center, on open science policy and transformation agreements, which ended with a question and answer session on the first day of training with interesting discussions, The participants had the opportunity to gain a deeper understanding of the topics of the day.

Responsible Research and Data Management (Day 2)

Tuesday, July 30, 2024

The second day shifted focus towards responsible research practices and data management. JYU opened the day with a session on **Responsible Research & Innovation** and the selection of **Trusted Publishers** by Kati Clements. During the presentation, Kati Clements stated that in order for research in Finland to be ethically acceptable and reliable, it must be conducted in accordance with the Finnish Code of Scientific Research Integrity, compliance with the European Code of Scientific Research Integrity, and the main principles of integrity of scientific research in the Finnish code of conduct are reliability, honesty, respect and accountability.

This was followed by a discussion on **FAIR Data & Research Data Management**, providing a robust framework for managing research data effectively. In the next presentation, in accordance with the FAIR (Findable, Accessible, Interoperable and Reusable) international standard to ensure the maximum reusability of research data, JYU provided information on data management that ensures the search, availability, interaction and reuse of research data and metadata. It was reported that major sponsors, such as the Academy of Finland, also require metadata and, if possible, data published when funded to be reliable.

The afternoon included a session on the European Open Science Cloud (EOSC) and its Applications, which illustrated the integration of open science practices into European research infrastructure. In his next presentation, the trainer explained that the European Open Science Cloud, known as EOSC, aims to create a "Trusted information and services network" for science in Europe, which will improve the situation for researchers in many ways, namely: expand scientific research opportunities by providing access to a large number of data and research results from different fields and institutions and said that it will promote innovation by facilitating researchers to share information, collaborate and build on each other's work.

The day concluded with a session on IPR - Ethics of Open Publishing, Copyright, and Legal Issues, offering participants crucial insights into the legal aspects of open science. The presenter said that the credibility of scientific research and society's trust in research rely on respect for good scientific practice and ethical considerations. Research ethics is part of the responsible conduct of research. Ethics review covers the whole research process. Research ethics issues may relate to the research topic, methods and practices, or the research data. These issues include ethical governance procedures, informed consent, anonymity of subjects and withdrawal from research. In addition, they concern research permits granted and pending. Dedication to the principles of good scientific practice is primarily the responsibility of each individual researcher and research team, but the responsibility is also shared by the director of the research unit and the management of the organizations conducting research.

A cultural trip to Goygol Lake provided a relaxing break, fostering informal interactions among participants and speakers. The day ended with a warm welcome dinner at the Haci Kent, Gold Garden Restaurant, where participants had the chance to network and reflect on the day's learnings.

Technical Aspects of Institutional Repositories (Day 3)

Wednesday, July 31, 2024

The third day delved into the technical aspects of institutional repositories. Gultekin Gurdal from IZTECH presented on the **Features of Institutional Repositories (IRs)** and the **Selection of Repository Software**, covering the essential components and considerations for effective repository management.

Presenter Gültekin Gurdal talked about what academic universities and researchers want, the advantages and reliability of academic archives, how institutional repositories comply with FAIR requirements, Confederation of Open Access Repositories (COAR) - the international association that brings together repositories and repository networks, the politics of archival work in Turkey, the number of archives Directory of Open Access Repositories (DOAR), academic archive types - EPrint, Dspace, Fedora Commons, Invenio, Dspace7 and informed about its advantages.

This was followed by a discussion on **Technical Requirements and Specifications** for setting up and maintaining institutional repositories. In his next presentation, Gultekin Gurdal explained in

detail the features, technical requirements, entities and relationships between entities, sections and subsections of Dspace 7.

Post-lunch, Aysen Binen from IZTECH conducted sessions on **Metadata Quality and OpenAIRE Guidelines** and **DSpace Data Entry Best Practices**. In this presentation, Aysen Binen spoke in detail about the features of the new generation of academic archives according to COAR, the application of quality metadata, standards, how to apply metadata in DSpace and Gcris, organizations that ensure the quality of metadata – Dublin Core, Open Access Infrastructure for Research in Europe (OpenAIRE), COAR. She put forward her proposals for increasing visibility of metadata and institutional repositories. Copyright details Sherpa Romeo and Creative Commons.

These practical sessions equipped participants with hands-on knowledge of metadata management and repository entry practices.

The afternoon concluded with an overview of **Research Data and IR: IZTECH Practices** by Begum Yavuz, highlighting best practices from IZTECH's experiences.

In her presentation, Begüm Yavuz spoke about the role of libraries in research data management, research - data storage strategy at IZTECH, obligations in data management, Zenodo system supporting researchers, long-term storage of data, Aperta (Turkish International Data Archive).

Practical Training and Policy Development (Day 4)

Thursday, August 1, 2024

The 4th day of the summer school was dedicated to practical work. Participants engaged in **Submission to Repository Practice** sessions, focusing on practical skills for uploading and managing data within repositories using DSpace. The participants of the partner universities of Azerbaijan were given assignments by Turkish experts. Each university, as a team, demonstrated the knowledge they acquired during the training by uploading metadata to the system in accordance with FAIR requirements. Turkish experts reported the completeness of the information and the presence of minor deficiencies.

After lunch, the focus shifted to the development of **Internal Repository Policies**. This collaborative session, led by JYU, IZTECH, and UNIVAQ, involved creating and refining policies to guide repository management and usage within participants' institutions.

At the end of the day, at the suggestion of European experts, each Azerbaijani university was instructed to make a presentation on the "Open science policy" of their universities for the next day.

Group Work and Conclusion (Day 5)

Friday, August 2, 2024

On the last day of the Summer school, Sharif Khurshudov gave an online presentation entitled "Managing Institutional Repository Digital Content: DSpace-CRIS".

The presentation provided information about the structure of the institutional repository, collections, registration, embargo, access permission. Among the institutional repositories intended to be implemented in partner universities within the project, it was emphasized that Dspace7 should be superior. Sharif Khurshudov's presentation was received with interest by the participants.

After Sharif Khurshudov's presentation, representatives of Azerbaijani universities - Aytaj Misgarli of Khazar University, Shukufa Aliyeva of BSU, Iltifat Ibrahimov of AZTU, Elvin Mejidov of ASCCA, Maryam Asadova of MSU, Aysu Rasulzade, who prepared a joint presentation of NSU and LSU, made a presentation on Open Access Policy for their universities. The presentations were welcomed by Turkish experts and recommended for future improvement.
